
Shares of Inheritance

Allah's commands concerning

Children's Share

If Deceased Heirs are -



^{**} The share of the one male should be double that of one female **

Children's Shares Continued

2 or more Daughters No Sons

2/3rd of the inheritance



1/3 inheritance goes to other heirs

Only one Daughter No Sons

1/2 of the inheritance



1/2 inheritance goes to other heirs

Only one son no Daughters

Full inheritance if no other heirs



if other heirs than remaining inheritance after giving everyones share

Parents' Shares

If Deceased has children

Mother = 1/6

Father = 1/6

Note: if children are either only daughters, only sons, both sons and daughters, just one son or just one daughter. **The remaining two-thirds** will be distributed among the rest of the heirs.

If Deceased has no Children and NO other heirs

Mother = 1/3

Father = 2/3

If Deceased has no Children and other heirs

Mother = 1/3

Father & other heirs = 2/3

If Deceased has no Children but brothers and sisters

Mother = 1/6

Father = 2/3 + 1/6 = 5/6

Note: If the parents of the deceased are alive, the brothers and sisters will not be entitled to any share in the inheritance.

All these shares are to be given after payment of the bequest (Wasiyat) the deceased might have made or any debts outstanding against him/her.

Spouse's Shares

If Deseased (wife or Husband) has NO children

$$Husband = 1/2$$

 wife/wives = $1/4$

If Deseased (wife or Husband) has children

$$Husband = 1/4$$

Husband =
$$1/4$$
 wife/wives = $1/8$



All these shares are to be given after payment of the bequest (Wasiyat) the deceased might have made or any debts outstanding against him/her.

Kalala

(man or woman who has no heir in the direct line - No Parents or Children)

This is for brother or Sister who share

Same Mother but different Father



Brother= 1/6

OR

Sister = 1/6

If 2 or more Brothers and Sisters

1/3 of inheritance to be shared among themselves



Rest 5/6 OR 2/3 will be given to Legal heirs (relatives)

if no legal heirs then rightful wasiyat if made to be followed

Kalala continued

(man or woman who has no heir in the direct line - No Parents or Children)

This is for Brother or Sister who share

Same Parents OR same Father

If Man dies and has only one sister (same parents OR same Father)

Sister = 1/2 of inheritance after inheritance of legal heir (wife) if present



If Man dies and has 2 or more sisters (same parents OR same Father)

Sisters = 2/3 of inheritance after inheritance of legal heir (wife) if present



If woman dies and has only one brother (same parents OR same Father)

Brother = Full inheritance after inheritance of legal heir (husband) if present



If Deceased (Man or Woman) has sisters and brothers

Male = 2 shares

Female = 1 Share
